 - *Unlawfully signing building permits for some residents*
 - *Unlawfully allowing construction projects without permits for some residents*
 - *Unlawfully denying or withholding building permits to some residents who qualify*
 - *Willfully and purposefully failing to enforce City Ordinances*
 - *Unlawfully signing checks*
 - *Failure to recognize authority of Majority vote or action of Council*


