- Item 12. Discuss/Take Action: TCEQ Letter of Enforcement Re: Water plant, fine, strategy, status: Discussed TCEQ letter regarding noncompliance issues from May-Oct 2021. Supplemental issue is water in sewer system, causing mosquitoes, flooded streets and culverts. A project working away from the plant and clearing culverts would reduce flooding and associated problems. This project would be funded with the \$16,000 from the Corona Virus money. No action from council.
- Item 13. Supplemental Environmental project; Biery moved to approve for supplemental project Torres seconded motion. All in favor
- Item 14. Discuss/Fake Action: Potential Developmental of vacant lots @ Luthardt and Gisler: Jimmy Heller presented a proposal for the development of properties @ Luthardt and Gisler St. Requesting the cities permission to add water and sewer connections. The city requested site maps/plans for the area. With help of City Inspectors Eric Kurecka and Earl Blum.
