On the 31st day after this order, the City of Austwell will exercise the Authority defined by this ordinance to remove the structure, and assess the property with a lien for the expense of removal, and administrative costs, and lien will be filed with the Clerk of Refugio County, incumbering the property until paid in full.

The owner of this building is ordered to submit plans and request permits to remediate deficiencies of report date 03/20/2023 by Bureau Veritas, or request a permit for demolition, within 60 days of date of this order. If repaired, work must commence within 90 days of the date of this order, and must be completed in 180 days of the date of this order, and receive a final inspection by Bureau Veritas confirming these repairs have been made if continual effort and progress is being made, extensions to these timeframes may be requested, and can be granted under the ordinance. All work must be accomplished according to current building and wind code standards.

Legal Owner: Reyes, Maria and Johnny Gutierrez

The Manufactured home located on this property has been determined to be substandard/unsafe, as defined by amendment 851 of Ordinance 121190, being windstorm and water damaged and deteriorated from its original design, as indicated by inspection report dated 3/05/2023.

Because this building is a manufactured home, and repair scheme must comply with standards of manufactured homes that are not listed in the IBC or IRC, which are the adopted standards for construction within the City of Austwell, repairs made to the roof, siding or structure of the manufactured home must begin with instructions/drawings bearing the stamp of a licensed professional engineer, following the guidance of TDHCA (Texas Department of Housing and Community Affairs) the regulating agency for manufactured housing in Texas.

The owner of this building is ordered to submit plans and request permits to remediate noted deficiencies of report dated 3/05/2023 by Bureau Veritas, within 60 days of date of this order, or remove the building from within the limits of the city of Austwell.

If Plans to repair are submitted, Work must commence within 90 days of the date of this order, and must be completed within 180 days of the date of this order, and receive a final inspection by Bureau Veritas confirming these repairs have been made. If continual effort and progress is being made, extensions to these timeframes may be requested, and can be granted under the ordinance. Repairs must be equal to or greater than the provisions of Windstorm II standards, and/or result in the issuance of a windstorm certificate.

If after 60 days, no plans are submitted for repair and permits requested, a new public hearing will be conducted, which may result in an order to remove or demolish.
